### **Speech From the Throne Opens the 3<sup>rd</sup> Session of the 5<sup>th</sup> House of Assembly**

**Wednesday 14<sup>th</sup>, January** - The House of Assembly of the Virgin Islands opened 2026 with its first sitting on Tuesday, 13<sup>th</sup> January, following prorogation. This marked the First Sitting of the Third Session of the Fifth House of Assembly, featuring the Speech from the Throne, Delivered by His Excellency, the Governor, Daniel Pruce.

Governor Pruce delivered on the theme, Legislative Pillars of Progress: Building a Sustainable Nation.

“Madam Speaker, the Second Session of this Fifth House of Assembly commenced on 7<sup>th</sup> January, 2025 and continued until 31<sup>st</sup> December 2025. By all indications, it was a very productive session, as the House deliberated on some 25 Bills, 21 of which were passed and 18 of which have been assented to”, Governor Pruce said. After His delivery, His Excellency the Governor declared the Third Session of the Fifth House of Assembly open.
